1. Health Ambassadors are keen to recruit new members – specifically from a Mental Health background. One opportunity to speak to Doncaster Mind or the People Focussed Group to identify a representative

2. Health Ambassadors agreed that they would like to write a letter outlining the continued need for a Deaf Community Development Worker and expressing their concerns that if this post does not continue then there will be a detrimental impact on a community of people who are seldom heard.

The letter should be sent to Dr David Crichton – Chair of NHS Doncaster CCG and Damian Allen – Director of People and Communities at Doncaster Council – it would be helpful to cc the letter to the Chair of Healthwatch Doncaster – Steve Shore – and the Portfolio Holder for Adults – Cllr Rachel Blake

3. Dennis Atkin will send around a report on Cancer services that was discussed by Karen Leivers at NHS Doncaster CCG's EEC meeting – Dennis would like comments, feedback and questions for a discussion at the next meeting on 30 November with Karen Leivers

4. Health Ambassadors have collectively agreed that the next meeting should take the form of an informal but structured conversation/discussion with a Commissioning Manger/Lead from NHS Doncaster CCG – the area of interest for the meeting on 30 November is Cancer and the Commissioning Manager/Lead to invite is Karen Leivers – it was also suggested that it would be useful to invite a cancer clinician to the meeting – Karen Leivers can identify the most appropriate clinician to invite.

Actions

CH to email Karen Leivers and invite her to the next meeting with the background to the informal but structured conversations around Cancer services and experiences

CH to develop a structure for the informal conversations around Cancer – the structure needs to be developed and shared with Health Ambassadors by 16 November so that any final tweaks and changes can be made so that the final structure can be shared with the agenda and papers on 20 November in advance of the meeting on 27 November.

5. There was a discussion around the Hospital Services Review that is being led by the Working Together Team as part of the Accountable Care System (ACS). The Working Together team would like to work with Healthwatch Doncaster to facilitate and support 3 community conversations with seldom heard groups. There need to be a minimum of 10 people in each conversation.

- Asylum Seekers and Refugees Julia Burne
- LBGTQ Cath Fox this can be linked into a screening of the Doncaster Pride video
- Deaf Community

CH to make links with PFG and arrange a community conversation at the PFG's next group meeting

AG to follow up potential dates and identify support for the community conversations around the Hospital Services Review

The conversations around the Hospital Services Review need to take place before the end of November 2017 if possible.

There was a brief update on the Missed Hospital Appointments work that is 6. being led by Healthwatch Doncaster – Health Ambassadors should have received an email update explaining the background to the work and links to the online survey.

Health Ambassadors are encouraged to share the info and the links to their survey through their networks and encourage as many people to get involved as possible.

The next phase of the Missed Appointments work is community-based engagement - are there opportunities for Healthwatch Doncaster to work closely with Health Ambassadors to support community sessions focussing on Missed Appointments in hospitals e.g Can Healthwatch Doncaster work with the Veterans group through Andy Martin and Ashworth Barracks or are there other groups and networks that the Health Ambassadors can identify to involve in the Missed Hospital Appointments work.
