3.	Minutes of the last meeting and matters arising	The minutes from the last meeting held on Friday 13 September 2019 were reviewed by the group and agreed as a true record.
4.	Ben Scott – Vision on Primary Care Networks - Julie Magee	Ben Scott (BS) gave an update on his vision and drive on Primary Care Networks (PCN). BS explained he is transparent in the way he works and passionate about having a community participation approach.

		BS mentioned the PCN would like to have a more integrated response and be more involved with patient engagement. Relationships would be developed by attending meetings such as general PPG meetings and PPG Network meetings. BS mentioned it would be useful to work with Healthwatch
		Doncaster as they have links with hard-to-reach groups. It was mentioned all views and opinions will be valued from the PCN as views from a patient side will be shared.
		BS also spoke about empowering patients to choose the right clinician for the right problem. This means ensuring patients attend the correct service. For example, if it is a small issue visit the chemist, and a major issue see their GP.
		A five year plan will be designed for patients to give their feedback about services that may be new or change in the future.
5.	Karl Roberts and Caroline Ogal – Doncaster CCG	Karl Roberts (KR) presented the new NHS app to the PPG network and explained the advantages to having the app. KR explained the app will not change or replace anything which is happening currently, however this will just be a more enhanced process where patients can look at booking appointments which they feel will be more suitable for them. App Doctor link: The app checks your symptoms, which then means the patient gets signposted to the relevant service, based on their stated symptoms. The patient can attend the service they have been signposted to, however from then they will be able to make an appointment with their GP. This is an advantage as the patient will receive a quicker response rather than waiting to get an appointment in person also the patient can check their availability and is easier for them to choose their own appointment.
		2020. There are currently six practices trialling the app however all practices are being contacted to enrol this design into their practices. 'Doctor link' are able to adapt the program to suit each individual practice.
6.	Sharing best practice	It was agreed that Peter Noble (PN) from Village Group Practice will discuss best practice at the next PPG Network meeting.
		Steve Lyons (SL) – Great North Medical Centre SL informed the network that the Chair at Great North Medical Centre PPG Patient Forum has resigned. A clinician has been invited to attend a PPG network meeting to represent the Great North Medical centre and listen to any concerns raised.
