PPG Network Action Points

KW informed the PPG Network on the new 'Extended Access Service' that has been introduced to improve access to appointments at a convenient time and location for patients and the service will be reviewed in 6 months' time. KW explained the 4 elements to the service:

- Saturday Morning clinics The clinics will be delivered in 4 hubs in GP practices across Doncaster. GPs can now refer you to one of the practices offering this service to get a Saturday morning appointment if cannot attend one throughout the week. All patients from any GP can attend the chosen GP practices for a Saturday appointment.
- Same Day Health Centre (SDHC) –GPs can book patients an appointment at the centre but appointments are limited. Patients can still selfrefer.
- 'First2Physio' service GPs will now refer patients to this service based at Devonshire House. The service is a triage and advice service that aims to reduce pressure on GP appointments for patients with musculoskeletal conditions or offer a triage and assessment service through physio nurses.
- Inclusion Health Clinics Drop-in clinics will be available for vulnerable groups using the RDaSH health bus based at convenient venues: Wharf House, The Conversation Club and Changing Lives.

Publicity resources are available on Primary Care Doncaster website.

HWD are completing surveys with patients on extended access.

There was a lengthy discussion on how the network felt strongly they should be more involved with PCD and felt perturbed that there had been no coproduction or had been asked to comment on the extended access posters.

It was proposed and agreed that the PPG Network will consider an affiliation with Primary Care Doncaster to achieve a closer link and also the importance in having a CCG representation at all network meetings to maintain this link. – Kayleigh Wastnage to attend November meeting.
