Minutes from last meeting</p> 	<p>Minutes & Notes of the last meeting held in 19 September 2018 were agreed and set as a true record.</p> <p>A question was asked about what John Burke had said in A.O.B-Healthwatch agreed to see if they can clarify what was said.</p> <p>It was noted that Louisa from Creative Support had agreed to send details of Drop in sessions to Emily Green to send to the members and these have not been received.</p>

<p>Actions from the last meeting</p> 	<p>Actions from the last meeting: There were no actions from the last meeting.</p>
<p>Racheal Long</p>	<p>Racheal explained what her job role entails and how she works with people who are at risk of committing a crime of terrorism. She works with individuals and people get referred through agencies. There was a short video which explained what her roles are and what people do whilst committing the crime.</p> <p>Racheal asked if anyone sees anything suspicious to say something to someone and they need to contact the police.</p> <p>All retailers have had training in shops and should know when someone is acting suspicious and what precautions to take if people are.</p> <p>The organisation is not an emergency service so if they receive a call or email they can take a few days to reply if they need to. Doncaster have been assessed and they are at a low risk of terrorism.</p>
<p>Kim Goldberg</p>	<p>Kim gave her apologies however she left some information about staying safe and well in winter.</p> <p>If anyone wanted any leaflets or information it was all available on the front table.</p>
<p>Doncaster Safeguarding Adult Board</p>  <p>John Woodhouse</p>	<p>Shabnum informed the group the agenda has been produced for the Keeping Safe Event but not circulated as yet, the date is the 18th December.</p> <p>'Lost Voice Guy' has confirmed he is available to perform at the event. There is more planning meeting available so come along if you would like to get involved.</p> <p>John Woodhouse spoke to the forum about any concerns they had about safeguarding and explained how the system worked. Has said that 'it is important for agencies to work together'.</p>
<p>Sally Brown – CCG</p>	<p>Sally Brown from Clinical Commissioning Group came along to the forum to discuss cancer.</p> <p>There will be a new screening test for Colorectal Cancer available from January. This will be available in GP surgery's.</p> <p>It should pick cancer up sooner as it has a high level of accuracy.</p>

	<p>There will be 3 tests on one day to save the public getting different appointments on different days. This will cause less frustration. Sheffield hospital will be sent the test once completed by the GP surgery's, the surgery will then get back to the patient with their results from the tests.</p>
